- 8) Open public hearing being held; with CPA Kris Kirk to speak on the proposed 2022-23 fiscal year budget, with possible public input. Proposed budget was published in the Siloam Springs Herald at least five days before this hearing.

  Rhonda spoke and advised board members need to review the proposed budget and they would vote on next month, since Kris is absent.
- 9) Discussion and possible action on allowing Waylon Chandler to start the annexation process for part of Hwy 412; extending our town limits from the intersection of Hwy 412 and County Rd 680 West approximately 1.2 miles to the intersection of Hwy 412 & County Rd 4775. Then extending our corporate limits from the intersection of E578 Rd (better known as Old Hwy 33 or Cedar Drive) West approximately 0.40 miles to the intersection of Hwy 412. (see attached map)
